CHAPTER 1 ALPACA SHOWS DEFINED

SECTION 1. For purposes of interpretation, ACSS where used in this Guideline means the ALPACA CANADA SHOW SYSTEM and includes its successors and assigns.

SECTION 2. The ACSS Alpaca Show Committee, where used in this Manual, shall mean that administrating body of individuals as assigned by the Alpaca Canada Board of Directors who shall be responsible for the drafting and implementation of said Manual defining Rules and Regulations as pertains to alpaca shows in Canada. The Alpaca Show Committee will also have the responsibility of maintaining the show rules by reviewing them on a regular basis, listening to membership input and making any changes if necessary on an annual basis.

SECTION 3. Alpaca Canada will be responsible for:

- a. overseeing the record keeping as pertains to alpaca shows
- b. designating a liaison for the ACSS Alpaca Show Committee.

SECTION 4. Immediate family shall be defined as: husband, wife, common-in-law husband, common-in-law wife, father, mother, daughter, son, brother, sister, father-in-law, mother-in-law, son-in-law, daughter-in-law, brother-in-law, sister-in-law, step-son or step-daughter as well as any of the foregoing that might be associated through a common-in-law relationship of a husband and wife.

SECTION 5. For purpose of interpretation the Grievance Committee will be a panel of 5 nominated individuals in good standing with Alpaca Canada and who represent a minimum of three (3) provinces. All shall be approved by the Alpaca Canada Board of Directors and must have a good working knowledge of the ACSS Manual. They will have no conflict of interest with the author of a grievance. As a condition of their presiding on the Grievance Committee they will be required to sign a statement of disclosure as well as take an oath of confidence to preserve the privacy of all matters of business of the aforementioned Grievance Committee. This committee will not be a permanent committee but one struck when a protest or grievance arises and disbanded once a solution is reached.

SECTION 6. This guideline is to be interpreted so that it does not infringe against the Laws and Acts of Canada or any regulation made under those Laws and Acts. Any provision that does so infringe shall be read down to the extent necessary to give it, if possible, an operation of a partial character, but if it can not be read down, it shall be deemed to be severable. If any provision is held invalid by a Court of Canada that provision shall be disregarded and the remainder of the Guideline shall continue in force.

CHAPTER 2 MAKING APPLICATION TO HOLD AN ALPACA SHOW

SECTION 1. Any club or association applying to hold an ACSS sanctioned show must:

- a. submit its application to hold a show along with a fee of one hundred (\$100.00) dollars to the ACSS Secretary as well as an additional hundred (\$100.00) dollars for each subsequent show it may wish to apply for in the same calendar year.
- b. provide a list of names and addresses of the judges whom it has selected. No judge's name shall be submitted without that judge's written agreement to do so.
- c. not advertise or publish the name of any of the judges which it has selected until the completed application to hold a show has been approved by the ACSS Alpaca Show Committee.

If the ACSS Alpaca Show Committee (ACSS Secretary) disapprove the application, the license fee will be returned to the club or association.

SECTION 2. A club or association must apply to the ACSS Secretary on a standard official form, which will be supplied upon request, over the signatures of one of its officers, for permission and approval to hold a show, stating in the application the day or days upon which, and the exact location where it desires to hold such a show. Application forms will be available at the Alpaca Canada Office or online in the Members section.

SECTION 3. ACSS secretary will not approve, sanction, be associated with or be held responsible for any sale held in either conjunction with a show or as a separate event.

SECTION 4. The ACSS Secretary will not approve a club's or association's application for show approval unless the club or association agrees to sign a waiver as supplied by the ACSS Secretary to indemnify Alpaca Canada and its successors and assigns from any and all insurance liability claims as may be filed by any individual or individuals that may have cause to make such a claim against said club or association applying to sponsor a show.

SECTION 5. All clubs and associations holding alpaca shows under ACSS rules must have available at each event, through their Show Management committees:

- a. a copy of ACSS Guidelines, Rules and Regulations for Alpacas which includes Show Management Guidelines
- b. because verification of identity of exhibits may be required, a scanner in good working order which is capable of reading the industry accepted standard of microchips which are implanted in alpacas.

CHAPTER 3. PARTICIPANT SHOW RULES

The following rules pertain to the responsibilities of the five major groups involved in the preparation and conduct of the show; SHOW MANAGEMENT, JUDGES, STEWARDS, EXHIBITORS and VETERINARIANS. For a full understanding of the show rules, all persons involved in showing should familiarize themselves with all the material.

A. SHOW MANAGEMENT

SECTION 1. A copy of the current ACSS Rules and Regulations shall be available on site. A show should be organized by the show management team according to procedures set down in the show schedule, as per the ACSS Rules and Regulations

SECTION 2. Show Managers, Stewards, Recorders, and Whipper-Ins are eligible to have entries in the show. However they should not personally exhibit any alpacas at the show they are working at.

SECTION 3. A member of the Show management should be available at all times and be familiar with ACSS and the official functions of the Show Management.

SECTION 4. The show management shall ensure that alpacas and fleeces are entered and exhibited in the correct classes.

SECTION 5. Show management must post time and location of exhibit inspection at the show.

SECTION 6. The Show Management shall ensure that a show catalogue is printed that records each class and details of every alpaca and fleece entered as exhibits.

SECTION 7. The Show Manager shall excuse an alpaca from being shown or excuse it from the premises if this is recommended by the veterinarian officiating at the show.

SECTION 8. Show Management shall be held responsible for the enforcement of all the Rules and Regulations for Alpaca Shows as set out by the ACSS.

SECTION 9. It is a requirement by ACSS that the Show Management upon closing of the Show on the published date, secure all Judge's records and immediately forward to Alpaca Canada in the provided format.

SECTION 10. Show management will establish its own cancellation and refunding policy

SECTION 11. Late entries may be accepted at the discretion of Show Management.

B. JUDGES

SECTION 1. Only those persons in good standing with and are currently certified by:

- a. the International Altiplano Judging School, otherwise known as IAJS,
- b. the Alpaca Owners & Breeders Association Show System, otherwise known as the AOBA Show System
- c. the Australian Alpaca Association, otherwise known as the AAA
- d. the British Alpaca Society, otherwise known as the BAS

Shall be approved as judges

SECTION 2. It is the responsibility of the exhibitor to prevent showing an alpaca before a judge where the judge was involved with the ownership, sale, brokering, promotion, breeding, training, management, boarding of the alpaca within the last 12 months prior to the date of the scheduled show.

SECTION 3. It is the responsibility of the judge to excuse any entry from a class should they recognize said entry as being the offspring of a sire or dam that they own or have owned an interest in within 2 years prior to the date of the show.

SECTION 4. The immediate family of a judge or any other individual that Show Management would deem to pose a conflict of interest in correct judging protocol may not exhibit alpacas at a halter show where the related judge is officiating as an alpaca judge. However, they may exhibit fleeces at that show. The immediate family of a judge may not enter fleeces at a show where related judge is officiating as a fleece judge. However they may exhibit alpacas in halter classes at that show.

SECTION 5. The judge shall not exhibit alpacas or alpaca fleece at any show at which he or she is judging both alpacas and fleece. However, a fleece judge may enter alpacas in halter classes at a show provided that he or she is judging only fleeces at that show. An alpaca judge may enter fleeces at a show provided that he or she is judging only halter classes at that show.

SECTION 6. A judge who, after agreeing to judge alpacas or alpaca fleeces at a show, receives an invitation to be the overnight house guest of any alpaca owner just prior to the show, shall make appropriate enquiry to establish whether that person intends to exhibit or handle alpacas or alpaca fleeces at that show, and shall decline the invitation if the person does so intend to enter said show.

SECTION 7. Judges must be knowledgeable and familiar with the current ACSS Rules. Judges are responsible for the correct interpretation and implementation of any and all ACSS Rules.

SECTION 8. On arrival at a show the judge shall meet immediately with show management.

SECTION 9. Judges must not engage in any candid conversations with any person or persons other than those directly associated with Show Management prior to and during his or her assignment

SECTION 10. A judge must not view the official show catalogue prior to or during judging and show management must ensure that no opportunity arises for the judge to see the show catalogue. The judge shall refuse to examine any catalogue that comes to his or her attention by any means until judging is completed.

SECTION 11. No person other than the Judge, Ring Steward, and exhibitors in each class shall enter the show ring during judging without the express approval of Show Management and Judge.

SECTION 12. The judge may direct the immediate disqualification and removal from the judging ring of any exhibit whose handler addresses or attempts to address the judge while the class is being judged, except in response to a request from the judge.

SECTION 13. The judge may in his or her absolute discretion direct the chief steward to remove an alpaca or person from the competition on the grounds of inappropriate and unacceptable conduct.

SECTION 14. The judge may in his or her absolute discretion direct the chief steward to remove an exhibit from the judging ring on the grounds of unsoundness or being unfit to compete.

SECTION 15. Judges must give oral reasons for their placements at the conclusion of each class

SECTION 16. The judge's decision shall be final. The judge has the right to withhold any, or all, prizes for want of merit. After a class has been judged in accordance with the ACSS Rules, it shall not be re-judged. A class is considered judged

when the judge has marked his or her class recording card which must be done before the next class is examined. Any changes to the class recording card must be initialed by the judge. No protest shall be made in relation to it except on the grounds that a judge has committed a breach of these rules. Any protest must follow proper procedures as defined in CHAPTER 10.

SECTION 17. A judge may protest against an exhibitor in the case of an alleged infringement of these rules by lodging a written protest to show management within 24 hours of the event and or the ACSS Grievance Committee as defined in CHAPTER 10.

SECTION 18 A judge shall be supplied with recording cards for all classes on which he or she shall mark all awards and all excused or disqualified alpacas. The Judge should be responsible for recording the number of entries in the class. The original judge's records shall remain in the custody of the show management upon completion of judging.

If a judge excuses or disqualifies an alpaca at any show, he or she shall make a note on the back of the class recording card giving his or her reasons for such disqualification or excusing.

SECTION 19. A judge's decision, as marked on the recording card cannot be changed by him or her after filing, but an error appearing in the judge's records may be corrected by the Show management after consultation with the judge.

C. STEWARDS

SECTION 1. A Chief Steward or Ring Steward may not exhibit alpacas at a show at which they are officiating as a steward. However they can have entries in the show. In the case of a Chief Steward someone else will be appointed to check their alpacas in. A Ring Steward can not steward a class in which their alpaca is being judged. A replacement Ring Steward will be made available. A Fleece Steward may not exhibit fleece at a show where he or she is officiating as a score sheet recorder, working with the judge.

SECTION 2. At a posted time by Show Management exhibitors must make their entries available to the Chief Steward for inspection. All class adjustments shall be determined by the Chief Steward with final approval of the Judge when necessary. Show management shall be notified of any class adjustments.

SECTION 3. Stewards' Inspection checklist

The steward's checklist for the inspection of alpacas shall include:

- a. general health and soundness
- b. microchip matching registration.
- c. correct colour, gender, age and fleece type for class entered
- d. Minimum mid side fleece length 2 inches
- e. deliberate shaping or clipping

Failure to meet these criteria may result in disqualification by recommendation of chief steward to show management.

SECTION 4. During the official inspection, the only persons present for the inspection of an alpaca will be:

- a. The exhibitor or his/her nominated representative
- b. The Chief steward
- c. If assigned, a person recording and validating the inspection information.

SECTION 5. The Chief Steward has the option to consult with the on call Veterinarian if the health of the alpaca is in question.

SECTION 6. The Chief Steward, Show Management and Judge may combine classes at their discretion.

D. EXHIBITOR ELIGIBILITY REQUIREMENTS

SECTION 1. All exhibitors will be required to pay an entry fee per alpaca entered. The amount of the said entry fee will be at the discretion of the Show Management Committee.

SECTION 2. All Exhibitors must be the registered owner of the alpaca entered. If in transition of ownership, permission to show forms will be provided. See attached form .

SECTION 3. **It is the responsibility of the exhibitor** to prevent showing an alpaca before a judge where the judge was involved with the ownership, sale, brokering, promotion, training, management, boarding of the alpaca within the last 12 months prior to the date of the scheduled show.

SECTION 4. Immediate family of the judge may not have entries in the show nor be a handler. Show management may not personally exhibit alpacas but they may make entries.

SECTION 5. It shall be **incumbent upon the exhibitor** to not enter any class where he or she is aware that the Judge has or has had an interest in ownership of the Sire or Dam of their entry within 2 years prior to the scheduled date of the Show

SECTION 6. An exhibitor or his appointed alternate who is unavailable to assist with the inspection of his or her alpaca(s) at the designated inspection time may have their entry disqualified.

SECTION 7. Exhibitor shall not engage the judge in conversation until the Judge has completed his or her judging assignment.

SECTION 8. Exhibitor shall not enter or exit the judging ring after judging of a class begins, until judging of that class has been completed and awards for that class have been presented except with the consent of the judge, or at the direction of the judge or chief steward.

SECTION 9. In the case of prize winning exhibitors and their alpacas, all shall remain in the judging ring until the completion of the Judge's comments.

SECTION 10. The handler of an exhibit in the show ring shall remain with the exhibit until judging has been completed unless authorized by the Judge.

SECTION 11. The following dress code shall apply:

- a. Dark pants or skirt and white shirt or blouse.
- b. Appropriate safe footwear (no open-toed shoes or sandals)
- d. No ranch, farm or personal logo or name shall be on the handler in the show ring.
- e. Show halter and lead shall be black without any adornments.

Failure to comply may result in disqualification.

SECTION 12. Every exhibitor and handler of alpacas at a show shall behave respectfully toward judges, show officials, other persons involved in alpaca classes and the general public during the show.

SECTION 13. Exhibitors must remain on premises until show has finished at the published time. Early departure may be authorized at the discretion of Show management.

SECTION 14. It is recommended that exhibitors should be 12 years of age to handle mature alpacas in the show ring.

E. VETERINARIANS

SECTION 1. Every ACSS certified show shall have a veterinarian familiar with camelids on call in an official capacity for the duration of the show.

CHAPTER 4. ALPACA ELIGIBILITY REQUIREMENTS

SECTION 1. **All alpacas to be entered in the show must be registered with the Canadian Llama and Alpaca Association (CLAA).** A copy of the alpaca's CLAA certificate of registration must be readily available at the show.

a. Pending registration status is not permitted. **A one year grace will be allowed for the first year that the ACSS rules are utilized.**

b. Percentage purebred alpacas with CLAA certificates of registration are eligible to show.

SECTION 2. An alpaca may be entered either into full fleece halter classes **or** the composite class but **not both** at any given show.

SECTION 3. Every alpaca must be entered in the name of the person or persons of legal record who actually owns the animal at the time the entries closed. Permission to show forms will be provided for those alpacas in midst of ownership change. See attached form.

SECTION 4. If an alpaca can not meet the requirements of the steward's inspection checklist it will be disqualified.

The steward's checklist for the inspection of alpacas shall include:

- a. general health and soundness
- b. microchip matching registration. *(There will be a one year grace period so that exhibitors become accustomed to checking their microchips before they get to the show and ensuring the paperwork matches)*
- c. correct colour, gender and age and fleece type for class entered
- d. Minimum mid side fleece length 2 inches
- e. deliberate shaping or clipping

SECTION 5. An alpaca cannot be surgically altered for cosmetic or conformational correction.

SECTION 6. Grooming shall be limited to removal of surface debris. Enhancements such as the use of sheens, dyes, and oils that compromise the true architecture of the fleece are prohibited. The alpacas fleece should display a natural growth pattern with no shaping or clipping other than top knots, tails, and lower legs below the front knee and rear hock joint.

SECTION 7. No ranch, farm, person's or alpaca's logo or name shall be exhibited on the alpaca during the class in which it is entered.

CHAPTER 5. HALTER CLASSES

A. CRITERIA

SECTION 1. **The Alpacas will be judged according to a breed standard.**

There will be no minimum class size. The judge does not have to award a first prize if there are one or more breed standard disqualifiers present. Refer to the Alpaca Canada Breed Standards attached.

SECTION 2. The Alpacas will be judged with the emphasis of 60% fleece and 40% conformation.

B. HALTER CLASS DIVISIONS

SECTION 1. Classes of 20 entries or less shall be judged as a single class. When a class reaches entries of 21 or more it shall be split equally according to age with each split receiving awards or by colour as defined in Section 2 d.

SECTION 2. Classes will be divided as follows:

- a. Alpacas will be divided into Huacaya and Suri
- b. Alpacas will be divided into male and female classes
- c. Age Divisions for Halter Classes:
 1. Juniors 6 months to under 12 months
 2. Yearlings 12 months to under 24 months
 3. Intermediate 24 months to under 36 months
 4. Seniors 36 months and over

d. Colour Divisions

An alpaca is to be shown in the appropriate colour class, when it is predominantly that colour. The alpaca will be disadvantaged, at the judge's discretion, if it has any other coloured fibres present. (e.g. spots or any other colour markings). The colour classes are:

1. White/Beige shall never be combined with any other colour.
2. Fawn
3. Brown
4. Grey/Roan
5. Black
6. Multi

An option available to show management is to split classes over 20 by colour instead of age. An example would be to divide the fawn class into light fawn and medium/dark fawn. White into white and beige. Grey into rose grey and silver grey. Black into bay black and true black. Brown into light brown and medium/dark brown. The colour split will have to be a minimum class size of six or the class would have to be split by age. (e.g. If there was only 5 light fawn in the class of 21 fawns then it would have to be split by age not colour). All colour splits would compete in their original colour group for championships

SECTION 3. Colour Definitions

- a. A current ARI Colour Chart can be used for colour differentiation

- b. An alpaca is to be shown in the multi class if it has any unusual or striking distribution of two or more colours that are distinct and immediately visible and are situated on the alpaca below the head and above the knees. Appaloosas, pintos and alpacas with white rings around the neck are examples of this designation. The colour pattern of the whole alpaca, not just its blanket shall be considered
- c. A predominantly grey alpaca is to be shown in a grey class, whether or not it has any other coloured spots present, grey alpacas may or may not exhibit a tuxedo front colour pattern. Variations will be assessed at the judge's discretion.

C. CLASS PROCEDURE

SECTION 1. Ribbons will be awarded to fourth place.

SECTION 2. Colour Champions

- a. Minimum number to award colour championship shall be 12 alpacas (Huacaya) 6 alpacas (Suri) per colour and sex.
- b. All first and second place alpacas in their respective colour and sex shall reenter the ring to compete for Colour and Reserve Colour champion.
(e.g. Junior black females, yearling black females, intermediate black female and senior black female would compete for black female colour champion and reserve).

c. There are 2 options for Colour Championships.

Option 1: Six colour classification groups.

- 1. White
- 2. Fawn
- 3. Brown
- 4. Black
- 5. Grey/Roan
- 6. Multi

Option 2: Three colour classifications

- 1. White
- 2. Fawn
- 3. Dark (Brown, Black, Grey/Roan, Multi)

SECTION 3. Supreme Champions

- a. Minimum number to award Supreme is 30 alpacas (Huacaya) 15 alpacas (Suri) in one sex and fibre type. b. All Colour Champions will come back to compete for Supreme. If there is no colour champion in your category, first place winners in their class shall compete for Supreme.
 - 1. Supreme Female Huacaya
 - 2. Supreme Male Huacaya
 - 3. Supreme Female Suri
 - 4. Supreme Male Suri

SECTION 4. (Optional) Best in Show

- a. At the discretion of Show Management, only the Supreme Male Huacaya/Suri and Supreme Female Huacaya/Suri may compete for Best in Show.

D. COMPOSITE CLASSES

SECTION 1. All Halter Class Criteria, Divisions and Class Procedures above apply to Composite Classes

SECTION 2. Composite Judging procedure

- a. Alpacas will be evaluated in a combined fleece and shorn conformation class.
- b. Fleeces will be submitted to Fleece Stewards prior to entry into the ring. It is recommended that the show employ TWO Fleece Stewards for this task
- c. The fleeces will be presented as a skirted blanket fleece. In the same way as you would exhibit in a Fleece Show.
- d. The Judge looks at the fleece and the alpaca together in the ring at the same time
- e. The fleeces are placed in the ring with the exhibitor number and the number of month's growth visible to the judge, in the same order as the alpacas enter the ring.
- f. The judge assesses the fleece using the same criteria as would be used in a full fleece halter class. The fleeces are judged on a comparative basis within the class.
- g. The judge assesses the alpacas in the ring using the same criteria as for full fleece halter classes. (i.e. general conformation, soundness and balance). Conformation is judged on a comparative basis within the class.
- h. The judge then places the alpacas using the comparative method of 40% conformation and 60% fleece.
- i. Exhibitors shall pick up their alpaca's fleece upon exiting the ring. Exhibitors are responsible for returning the appropriate fleece for championship classes.
- j. The fleece shown must be from the most recent shearing of the alpaca entered.

E. GROUP HALTER CLASSES:

SECTION 1. All entries in group halter classes shall be in full fleece.

SECTION 2. Get of Sire

- a. Entry shall consist of three progeny by the same sire.
- b. Entry shall be made in the name of the sire.
- c. Sire Owner's signature shall be required on the entry form, as approval of his entry in this class.
- d. There shall be only one group entered per sire.
- e. All progeny must have been shown in their appropriate halter class.
- f. Offspring must be from a minimum of 2 dams.
- g. The sire is not shown in this group entry.

SECTION 3. Produce of Dam

- a. Entry shall consist of two progeny from the same dam.
- b. Dam Owner's signature shall be required on the entry form, as approval of her entry in this class
- c. There shall be only one group entered per dam.
- d. All progeny must have been shown in their appropriate halter class.
- e. The offspring must be from 2 different sires.
- f. The dam is not shown with this group entry.

F. YOUTH SHOWMANSHIP (Optional)

SECTION 1. In this class the young exhibitor's ability to showcase the alpaca is being judged. The alpaca itself is not judged.

SECTION 2. It is recommended that exhibitors should be 12 years of age to handle mature alpacas in the show ring.

SECTION 3. Class Divisions:

- a. Junior Youth Showmanship – Exhibitor age: 6 through 12 years on the first date of the show.
- b. Senior Youth Showmanship - Exhibitor age: 13 through 18 years on the first date of the show.

CHAPTER 6 FLEECE CLASSES/SHOW

This competition may be held at the same time as the Halter Classes but in a separate secure area as designated by Show Management or it may be held as a stand-alone show.

A. FLEECE CLASS DIVISIONS

SECTION 1. Fibre Type Division - Huacaya and Suri

SECTION 2. Age Divisions(i.e. age of the alpaca when it is shorn)

- a. 6 months – under 14 mo. – 1st fleece - A
- b. 14 months – under 24 mo. - B
- c. 24 months – under 4 years of age - C
- d. 4 years of age – under 6 years of age - D
- e. 6 years of age and over – E

SECTION 3. Colour Divisions: Same options as for Halter Classes

SECTION 4. Sexes shall be combined for all classes

B. RULES GOVERNING FLEECE COMPETITION

- a. Each fleece entry must be accompanied by a completed entry form as provided by Show Management giving requested information. A copy of the Alpaca's CLAA registration certificate must accompany the entry form.
- b. The fleece shall be presented in clear plastic bags and have the required exhibitor information included **in** the bag.
- c. Show Management will not be held responsible for loss or misplacement of the fleece although every possible effort will be made to ensure the security of the fleece.
- d. The exhibitor shall be solely responsible for claiming their fleeces at the end of the show.
- e. No fleece under 6 months of age is eligible for fleece competition.
- f. Fleece must be from the most recent shearing of the alpaca.
- g. Fleeces with less than 3 inches (76mm) staple length shall be disqualified.
- h. Fleeces older than 14 months since shorn shall be disqualified.
- i. Maximum fleece length:
 1. JUNIOR CLASS (A) There is no maximum staple length for this age category.
 2. ALL OTHER AGE CATEGORIES - maximum of 6.5 inches (16.51cm) Any fleece that exceeds maximum staple length will be disqualified.
- j. The Show Management Fleece Steward shall weigh each fleece and calculate for age conversions if required, check for correct classing and provide each fleece with a judge's scorecard identifying the fleece by **number only**.
*NB. Weight to age conversions are calculated as follows:
Weight divided by number of days of growth, multiplied by 365.*
- k. Show Management shall provide adequate lighting for the judging of fleeces, a weigh scale, calculators, score cards and appropriate stationary items required for adequate record keeping.

C. FLEECE PREPARATION

All fleece exhibits shall be the prime portion only which must conform to the same quality and length of the blanket area and shall be skirted of all short, stained and other fibre that does not conform to the same quality and length of the blanket area. Once it is determined to be free of parasites it should be properly skirted and all short, stained and coarse fibre as well as heavy organic contamination should be removed and the fleece shall be presented with cut side displayed out for huacayas and cut side in for suris. **The fleece shall not be washed.** Poorly prepared fleeces shall be compromised at the discretion of the judge.

D. FLEECE CLASS AWARDS:

SECTION 1. General Fleece Classes

In order for a fleece to achieve a first place award in a class the judge must award a MINIMUM score of 60 points. If no fleece in a class accumulates the minimum of 60 points, the class shall begin with a second place award.

- a. Ribbons will be awarded to fourth place.

b. Colour Champion and Reserve Colour Champion in each colour class for Huacaya and Suri First and Second place fleeces will compete for Colour and Reserve Colour Champions.

c. Supreme Huacaya, Supreme Suri - Colour champions compete for Supreme.

Above placings will be directly related to score awarded.

Colour Champions use same options as in halter classes: 6 colour classifications (white, fawn, brown, black, grey/roan, multi) or 3 colour classifications (white, fawn, dark).

Unlike halter classes, there will be no minimum number competing in order to be awarded colour champion or supreme. These fleeces will have to have achieved the minimum score of 60. In the future after some data has been acquired there may be different minimum scores for colour champion and supreme fleeces.

Fleece scorecards shall be provided for the judge by the show convener and shall be formatted individually for Suri and Huacaya fleeces. Each exhibit shall have its own scorecard and the scorecard shall remain with the fleece at all times. Identification shall be the official exhibit number issued by the convener at the time the exhibit is delivered for judging. No other identification shall be allowed on the scorecard or the fleece exhibit. *Note: See end of Manual for sample scorecards & judge's work sheet*

These awards may or may not be awarded at all shows. These awards are not based on final score awarded.

E. FLEECE SCORING CRITERIA FOR HUACAYA:

SECTION 1. AIMS

The aims of Alpaca Fleece Judging are to provide a competition which recognizes those characteristics of Alpaca which are desired by manufacturers /processors, producers and enlightens those persons interested in the Alpaca industry.

The purpose of these explanatory notes is to enable all judges of Alpaca to approach the assessment task using the same common information and standards. This should enable uniformity of judging.

SECTION 2. MAXIMUM POINTS AWARDED

Fineness and Handle	25 points
Uniformity of Micron	10 points
Brightness	10 points
Uniformity of Colour	5 points
Character	10 points
Uniformity of Length	5 points
Density	5 points
Impurities/Stain/Tip Damage	5 points
Medullation	10 points
Clean Fleece Weight	15 points
Total:	100 points

In developing this judging schedule, fleece quantity and quality have been given equal status. It is important that fleeces which are either "very pretty and no weight" or "very heavy and no style" do not gain advantage because of their style or weight alone, but have a good combination of both.

SECTION 3. EXPLANATORY NOTES

a. FINENESS AND HANDLE - This reflects the degrees of actual fineness of fibre displayed, expressed in microns as well as taking into consideration various levels of softness. When assessing fineness and handle consideration should be given to the age of the animal or class in which the fleece is entered.

1. FINENESS (see attached table)

2. HANDLE

This assessment reflects the relative degree of softness displayed by individual fleeces taking into consideration the age of the animal and micron of the fleece.

Very soft - 5 points

Soft – 4 points

Normal – 3 points

Hard – 2 points

Harsh - 0/1 points

b. UNIFORMITY OF MICRON

This relates to the evenness of fineness/softness throughout the entire fleece.

Very even / Even - 8/10 points

Some irregularity - 5 / 7 points

Irregular - 3 / 4 points

Very Irregular - 0 / 2 points

c. BRIGHTNESS

This relates to the light refraction of the Alpaca fibre taking into account breed type.

High - 9/10 points

Good - 7 / 8 points

Average - 4 / 6 points

Dull / Poor - 0 / 1 points

d. UNIFORMITY OF COLOUR

This relates to the evenness and regularity of colour throughout the entire fleece. Fancy are not judged for uniformity of colour.

Good Uniformity - 5 / 4 points

Some Irregularity - 3 / 2 points

Very Irregular - 1 / 0 points

Total score for fancy fleeces will be out of 95 and then calculated to a percentage.

e. CHARACTER and STYLE

This relates to the wave/crimp and crinkle within the staple relevant to the fibre type.

Very well defined Crimp/Crinkle - 9 /10 points

Good definition - 7 / 8 points

Average definition - 5 / 6 points

Poor/Plain definition - 3 / 4 points

Straight fibred - 0 / 2 points

f. DENSITY

This relates to the density of the individual staple formation throughout the entire fleece.

Very dense - 5 points

Good density – 4 points

Average - 2 / 3 points

Thin/without substance - 0 / 1 points

g. UNIFORMITY OF LENGTH

Relates to the uniformity of length throughout the entire fleece taking into consideration commercial lengths over 12 months growth period.

Note: make deductions for over long or short fleece.

Very even - 5 points

Some irregularity - 4 / 5 points

Irregular - 2 / 3 points

Very irregular - 0 / 1 points

h. IMPURITIES

Penalties should be applied for excessive vegetable matter, staining within the fleece and/or any excessive tip damage.

Penalties should also apply for excess sand or dirt.

Pt tender - 2/3 points
Tender or rotten fleece - 0/1 points

i. MEDULLATION – GUARD HAIR CONTENT

The fleece should be as free as possible from narrow/broad continuous medullated fibres, which appear as straight, generally coarser fibres. Age and class should be considered.

Free or nearly free - 9 /10 points
Light content - 7 / 8 points
Medium content - 4 / 6 points
Heavy content - 0 / 1points

f. CLEAN FLEECE WEIGHT (See attached table)

This relates to the percentage of properly skirted clean fleece (fibre) after removing all extraneous matter (dirt, grease, burrs, seeds, and dung tags).

NB. Fleece weights shall be scored relative to fleece weights presented in the competition. It will be at the discretion of the judge to withhold any score should the judge determine the fleece to be unacceptably light in weight.

Note: 1 kg = 2.2046 lbs.

Assume 90% yield

e. STYLE

This relates to the twist/wave within the staple relevant to the Suri breed type. This assessment is based on the most desired lock for breeding. Although the majority of types/styles listed below would be satisfactory for processing, some are more desirable than others.

Ringlet type which starts twisting close to the skin. - 10 Points
Slight wave with twist starting close to the skin. – 9 points
Either of the above, which do not start its style close to the skin. - 7/8 points
Larger wave with slight twist. - 5/6 points
Straight with a slight twist on the end. – 4 points
Bold large crimp like wave. (Huasu) – 3 points
Straight/plain with luster – 2 points
Straight/chalky – 1 points

CHAPTER 7. AWARDS

A. RIBBONS:

Ribbons shall be awarded to a maximum of fourth place.

Mandatory Ribbon Colours are:

First Place- Red

Second Place - Blue

Third Place – White

Fourth Place – Yellow

B. PRIZE MONEY and TROPHIES:

Prize money may be offered at a show at the discretion of Show Management. Trophies may be presented in addition to or in lieu of ribbons, provided that they recognize specific awards within the ACSS Show System.

C. CANCELLATION OF AWARDS

During a show, if any award is revoked or cancelled, the alpaca judged next in order of merit shall be moved up one placing. If there is no alpaca to move up, the award shall be cancelled. Once the show is complete, if any award is revoked or cancelled, it shall not be re-awarded, and original class placing will remain unchanged. It is incumbent upon the exhibitor to return revoked awards to Show Management within ten days of notice.

CHAPTER 8. REGISTRATION AND SHOW PROGRAMS

A. ENTRY PACKAGE

The entry package shall contain the following:

- a. The ACSS Sanction number shall be published in the Show Catalogue
- b. the names of the judges and with their assignments
- c. location of the show,
- d. the date or dates on which it is to be held
- e. entry closing date
- f. Requirement for late entries if applicable
- g. the times of the opening and closing of the show
- h. number of alpacas allowed per pen and/or pen size
- i. Entry Form (refer to example and ACSS code key attached)

B. THE SHOW PROGRAM

The Show program shall contain the following:

- a. Show name
- b. Location of the show
- c. The date

- d. The name of the judge
- e. ACSS Sanction number
- f. Class list
 - 1. Alpaca Class Code Number
 - 2. CLAA registration number
 - 3. Date of Birth
 - 4. Name of Sire and Dam
 - 5. Name of Owner

CHAPTER 9. PROTESTS AND DEALING WITH MISCONDUCT

SECTION 1. Conduct that may be considered prejudicial to the industry may include but not be limited to:

- a. a demonstration of dissatisfaction with a judge's decision, including refusal to accept an award or throwing an award on the ground,
- b. altercations with officials or participants,
- c. abusive or foul language in public and mistreatment of an animal.

SECTION 2. Judges who are the target of abusive language and under whom an exhibitor refuses to follow their instructions, as well as being insulted with any suggestive language, gestures or request should report directly to Show Management. In addition, they may submit a grievance to an ACSS Grievance Committee member directly if in attendance of the Show or as per the following SECTIONS 3 and 4 as outlined for exhibitors.

SECTION 3. Exhibitors who have a complaint, protest, criticism, comment or suggestion shall direct all or any of the preceding concerns to the Alpaca Canada Show System Grievance Committee as follows:

- a. Must be in writing and signed by the exhibitor who has an issue to be dealt with.
- b. rational and complete description of events that transpired must be included as well as stating names of those witnessing the transgression if possible and who would attest to the fact that such an act of misconduct occurred.

SECTION 4. Said signed complaints, protests, criticisms, comments or suggestions must be postmarked within 15 days after the scheduled closing of the approved show and shall be held in the strictest of confidence.

SECTION 5. A fee of \$50.00 must accompany all written complaints, protests, criticisms, comments and suggestions.

SECTION 6. Anonymous letters of any critical intent will not be accepted or read.

SECTION 7. All signed complaints, protests, criticisms, comments and suggestions will be reviewed by the ACSS Grievance Committee and replied to by the Alpaca Canada Show System Grievance Committee in as efficient a manner as possible.

SECTION 8. All written and signed decisions handed down by the ACSS Grievance Committee will be final and absolute.

SECTION 9. Any Grievance Committee member who is the subject of a complaint, protest, or criticism shall be excluded from any discussion or review by the Grievance Committee and if justified will be disciplined by the Alpaca Canada Board of Directors as per the recommendation of the remaining members of the Grievance Committee.

SECTION 10. Disciplinary action may include, but may not be limited to, the following:

- a. Show Management
 - i. Written warning
 - ii. Denial of future show approvals
- b. Judges
 - i. Written warning
 - ii. Removal from Alpaca Canada Approved Judges' List
- c. Exhibitor
 - i. Written warning
 - ii. Points and or awards revoked
 - iii. Denial of eligibility to participate in any approved show or event.
